### QUALIFIER INFORMATION:

- Contestants may DUAL qualify for Vegas Tuffest and the Junior World Finals.
- Membership and sidepot fees are required to be eligible. Contestants must have a paid membership prior to competing, pay entry fee(s), and side pot fee(s). Side pot money is paid back to Contestants as added money in their event/age division in Las Vegas.
- Each entry is 2 go-rounds/runs. Contestant may enter an event two times (2x) (4 go rounds/runs), but Contestant will only qualify one time (1x) for each event.
- All Events are jackpotted and awards are given in every event/division by the Wild Bunch Ranch.
- Membership is not required to participate in the Wild Bunch Jackpot.
- Age is determined as of January 1 of the calendar year (for both qualifiers).
- Stalls are available @ \$15.00 each, per night.

## 2024 Release of Liability and Hold Harmless Agreement

To be completed by Contestant (if over 18 years of age), or Parent of Minor Participant/Contestant

This Release of Liability and Hold Harmless Agreement is entered into between The Wild Bunch Ranch & Arena along with Bradley and Jodi Ann Goodrich and the persons named below, for those persons(s) participating in horse activities using horses owned by Bradley and Jodi Ann Goodrich, or if riding their own horse on the property owned by Bradley and Jodi Ann Goodrich and the person(s) executing this document (hereinafter referred to as "Participant")

BY SIGNING THIS DOCUMENT, PARTICIPANT ACKNOWLEDGES THAT THERE ARE INHERENT RISKS IN USING AND BEING AROUND HORSES. THOSE RISKS INCLUDE BODILY INJURY AND DEATH. PARTICIPANT UNDERSTANDS THAT HORSES ARE UNPREDICTABLE AND CAPABLE OF SUDDEN, UNEXPECTED, AND POTENTIALLY DANGEROUS MOVEMENTS DESPITE THEIR PRIOR HISTORY. PARTICIPANT FURTHER UNDERSTANDS THAT HORSES ARE EASILY FRIGHTENED BY SOUND, SUDDEN MOVEMENT, UNFAMILIAR OBJECTS, ODORS, PERSONS, AND OTHER ANIMALS. THEY MAY RUN, BITE, BUCK, OR KICK. HORSES MAY ALSO ENCOUNTER NATURAL HAZARDS, SUCH AS SURFACE OR SUBSURFACE CONDITIONS AND REACT UNPREDICTABLY. RIDERS CAN ALSO FALL OFF OF HORSES AND INJURE THEMSELVES. PARTICIPANT ACKNOWLEDGES THAT BRADLY AND JODI ANN GOODRICH, OR AGENTS ACTING ON BEHALF OF BRADLEY AND JODI ANN GOODRICH, ARE NOT LIABLE FOR THE DEATH OR INJURY TO A PARTICIPANT RESULTING FROM THE INHERENT RISK OF LIVESTOCK ACTIVITIES.

In consideration for riding and/or being around horses owned or under the care of Bradley and Jodi Ann Goodrich, Participant(s) voluntarily agree to the terms of this RELEASE OF LIABILITY AND HOLD HARMLESS AGREEMENT. Participant agrees to personally assume the risks associated with riding and otherwise being on or around horses. Participant hereby releases, waives, and forever discharges Bradley and Jodi Ann Goodrich or agents acting on behalf of Bradley and Jodi Ann Goodrich, of all actions of whatever kind or nature either in law or in equity arising from or by reason of any bodily injury or personal injuries known or unknown, death, or property damage resulting during the Participant's presence on the property owned or leased by Bradley and Jodi Ann Goodrich, including injuries, property damage, or death arising from riding or otherwise being on or around horse so long as such injury, property damage, or death is not caused by an intentional, willful, or wanton act or omission of Brittney Beamer (i.e. Participant releases Bradley and Jodi Ann Goodrich from liability of damages caused by Bradley and Jodi Ann Goodrich's negligent acts or omissions only). Participant assumes full responsibility for the risk of bodily injury, death, or property damage, and shall hold Bradley and Jodi Ann Goodrich harmless for any liability thereof as set forth herein.

This release is given on behalf of Participant, and in the case of any child or children of Participants on behalf of them as well. This release is an ongoing release and remains in effect until Participant has revoked it in writing. Participant understands that this document is a contract and agrees that if a lawsuit is commenced against Bradley and Jodi Ann Goodrich, agents and/or employees for any injury or damage allegedly caused by, or allegedly attributable to, Bradley and Jodi Ann Goodrich, Participant will pay all attorney's fees and costs reasonably incurred by Bradley and Jodi Ann Goodrich to defend that lawsuit so long as such alleged injuries or damages are not the result of intentional, willful, or wanton act of Bradley and Jodi Ann Goodrich.

By signing this RELEASE OF LIABILITY AND HOLD HARMELSS AGREEMENT, I (the parents, or legal guardians of the Participant), agree to and understand ALL the terms of this AGREEMENT as described above.
