

2026 Code of Conduct

ALL Contestants and Parents/Guardians, on behalf of themselves and the Contestant, are bound by and must adhere to the following Code of Conduct throughout the qualifying year including the finals. All Contestants and Parents/Guardians will be required to affirm his/her adherence to this Code of Conduct during registration. *Even if a Contestant or Parent/Guardian does not sign the Code of Conduct or otherwise affirm his/her adherence to it at registration, he/she is still bound by the Code of Conduct because it is also posted at the event.*

- Contestants and Parents/Guardians shall conduct themselves in a professional and respectful manner, treating fellow Contestants, Parents/Guardians, organizers, staff, judges, and others with courtesy and respect. Any unprofessional, disrespectful, profane, dishonest or criminal activity is strictly prohibited and may result in disqualification, suspension or permanent banning of the Contestant or Parents/Guardians from the event, future events and/or membership, as determined by and in the sole, exclusive and complete discretion of MJ Vegas Tuffest Productions LLC.

- Contestants and Parents/Guardians shall refrain from engaging in any behavior that may bring discredit or harm to the Vegas Tuffest Jr. World Championship or reputation of the event.

- Contestants and Parents/Guardians shall refrain from bullying behaviors, including those based on different backgrounds, cultures, and beliefs, and any behaviors that may be deemed discriminatory or prejudiced.

- Contestants and Parents/Guardians shall exhibit good sportsmanship throughout the event, both in and out of the arena, and shall display respect and support for their fellow Contestants and other Parents/Guardians.

- Contestants and Parents/Guardians shall conduct themselves with the highest standards of integrity and honesty in all aspects of the event. This includes behavior before, during and after competitions; interviews; interactions with the public; and posts or comments made in online forums and social media platforms. Cheating is strictly prohibited.

- Contestants and Parents/Guardians shall provide Vegas Tuffest Jr. World Championship staff with accurate and truthful information about the Contestant and/or Parents/Guardians and their qualifications, avoiding any form of misrepresentation or deceit.

- Contestants and Parents/Guardians shall exercise responsible and respectful behavior, maintaining a positive and constructive online presence on all social media platforms and online forums. Contestants and Parents/Guardians shall avoid any actions or statements that may be deemed discriminatory, or which would be prejudicial to or negatively impact the Vegas Tuffest Jr. World Championship event, Contestants, representatives or staff.

- Contestants and Parents/Guardians shall seek clarification from the Vegas Tuffest Jr. World Championship office if they have any questions regarding the rules or requirements of the event, including this Code of Conduct.

- Contestants and Parents/Guardians are expected to serve as positive role models, promoting goodwill and community engagement as representatives of their sport.

- Contestants, Parents/Guardians, and patrons of the event shall not engage in disruptive behavior before, during, or after the event. Assaulting, degrading, cursing, or yelling at another Contestant, Parent/Guardian, Judge or Staff Member is strictly prohibited.

- Contestants and Parents/Guardians shall treat the animals participating in the event with respect and dignity, and shall not intentionally harm any animal on the event premises.

- Any violation of this Code of Conduct may result in immediate disqualification and/or forfeiture of ALL prizes and awards won at any Vegas Tuffest event throughout the year including qualifiers & the finals and the right to revoke current membership and/or to refuse membership of contestant in future years.

- All issues related to this Code of Conduct and consequences for violation thereof shall be determined solely and exclusively by MJ Vegas Tuffest Productions LLC and/or the Vegas Tuffest Jr. World Championship event representatives. Contestants and Parents/Guardians agree to accept such determinations as to themselves and others.
